- The opportunity to run for the Board of Directors
- Participation in the running of The Roxy and the operation of Owen Sound Little Theatre through membership on one or more of the Committees
- The opportunity to participate in any of the OSLT productions as cast or crew
- The opportunity to share your skills with other members in workshops, mentoring or apprenticeship programs
- Various social occasions during the year, like cast parties, a Christmas party and other spontaneous get-togethers
- Development of your interests and skills in workshops, mentoring and apprenticeships
- Training that will be available to you: AODA, SmartServe (if applicable), Working From Heights (if applicable)

- Payment of annual fee – **due 12 months after purchase**
